## ARTICLE IV: DUES

SECTION I:

## CURRENT WORDING:

An active member is one who pays yearly dues. Membership dues are renewable yearly. Dues run from the date of application through June 30th, renewal year is then July 1st through June 30th. There are no partial dues. (Amended July 2012).

## RECOMMENDED WORDING:

An active member is one who pays yearly dues. Membership dues are renewable yearly. Dues run from the date of application through December 31, renewal year is then January 1 through December 31. There are no partial dues.

Amendments shall become effective upon the meeting at which adopted.

## RECOMMENDED WORDING:

These By-Laws may be amended at the January Annual Meeting or the May General Meeting by a two-thirds (2/3) vote of the members present, providing the proposed written amendment has been submitted at a Board of Directors meeting within the previous three (3) months. Amendments shall become effective upon the meeting at which adopted.
