


**Theatre Update** – Renovations at the Sugden Theatre (home of the Naples Players) are behind schedule.

**Program Director "OPEN"** 

February 14, 2024 Brittany Piersma Field Biologist Audubon Western Everglades (AWE)

I am pleased to present our Valentine's Day speaker, Ms. Brittany Piersma! Brittany will speak to the membership regarding the 3 critical conservation projects here on Marco: Burrowing Owls, Gopher Tortoises and Shorebirds.

Brittany has a BS in Environmental Science and previously worked as a zookeeper at the Naples Zoo for 4 years. She has a wide range of experience with Southwest Florida's wildlife from volunteering with FWC (Florida Fish & Wildlife Conservation Commission), Rookery Bay, Panther Refuge, and Audubon.

Ms. Piersma worked as FWC's Critical Wildlife Area Shorebird Biologist for the last three summers on Marco Island, where she monitored nesting shorebirds out on Sand Dollar. The last two winters she worked as a Shorebird Steward for Audubon Western Everglades surveying the migratory flocks, training volunteers, and doing outreach with the public.

As Field Biologist for AWE, Brittany maintains continuing wintering bird surveys, assists with the burrowing owl program as well as our new Gopher Tortoise land study.

March 13, 2024 Stephen McGuire Retired Federal Judge

Steve McGuire had a 30+ year legal career serving as an attorney and a federal judge in Washington, DC. Steve retired in 2008 as the Chief Judge of the Federal Trade Commission, where he received its Distinguished Service Award and was honored by President George W. Bush for his service to the nation's judiciary. Prior to FTC, he was an Administrative Law Judge at the Social Security Administration and the Environmental Protection Agency. He has two certifications from Harvard University, one from the John F. Kennedy School of Government, and the other from Harvard Law. Subsequently, he became Vice President for Corporate Compliance at the University of

Louisville Hospital.

He has traveled to over 65 foreign countries, including 10 communist countries. Among his more memorable trips were those to Cuba (where his letter about the culture and lifestyle of Havana was published by Cigar Aficionado magazine), Africa, India, Vietnam, and Japan. In July 2019, he taught English to high school students in the Fujian Province of China.

Steve has authored three political thrillers, Prior Restraint, Fractured Power and Secret Deceit. He has appeared at over sixty speaking engagements in the past three years at bookstores, book clubs, libraries, country clubs, civic associations, art centers, and radio shows. Steve has been interviewed in over twenty radio shows and podcast; and featured in newspapers around the country, as well as in Spain and United Kingdom. He is a native of Louisville, Kentucky. He lives in Naples, Florida, with his wife, Doris, their golden retriever, Henry and a mini goldendoodle, Alfie.

April 10, 2024 Lt. Brian Sawyer Collier County Sheriffs Officer

Lt. Sawyer will speak on the current state of fraud against seniors, what the county is seeing, and how to protect ourselves.

Sawyer has been a member of the Collier County Sheriff's Office for 23 years. He joined the Crime Prevention Unit in 2018 from a long tenure in

Criminal Investigations. He is a Hostage Negotiator; having previously been a member of the SWAT Team for 16 years. He has a Master's Degree in Public Administration, a Graduate Certificate in Global Strategic Communication, and is a graduate of various leadership academies including the Command Officer Development Course and FDLE's Florida Leadership Academy. He is married to his wife, Sonya, and they have two children ages 10 and 13. He and his family are very active in community philanthropies which include: The Friends of Foster Children, the American Heart Association, and the SWFL Wine Fest. Sergeant Sawyer loves living in Collier County and can attest to the fact that this community, along with the Collier County Sheriff's Office, truly demonstrate that this is a great and safe place to live.

# February Golf News


